By signing this agreement, you are giving up certain legal rights, including the right to recover damages in case of injury, death, or property damage, arising out of your use of horses, riding and/or participation in equine activities at Horses for Good. Read this agreement carefully before signing it. Your signature indicates your understanding of, and agreement to, its terms.

By signing this agreement, I hereby acknowledge on behalf of myself that I have familiarised myself with the activities that I will be allowed to participate in, and that I do hereby acknowledge and agree that I will participate in these activities without restriction or limitation. I recognise the "inherent risks of equine" means those dangers and conditions that are an integral part of Equine Activities, including but not limited to:

The propensity of a horse to behave in ways that may result in damage to property or injury, harm or death to persons on or around the horse.

Such equine behaviour includes but is not limited to bucking, shying, kicking, running, biting, stumbling, rearing, falling and stepping on.

The unpredictability of a horse's reaction to such things as: sounds; sudden movements and unfamiliar objects; persons or other animals; collisions with other equines or objects, persons or other animals; unpredictable or erratic actions by others relating to equine behaviour; scratches or other injury from stables or enclosures; scratches or other injury from grooming tools and other equine equipment and tack; allergic reactions to animals, hay or other allergens; tripping in holes, on materials, equipment or uneven surfaces; slipping, falling, or otherwise being injured in the barn, in stalls, or on the grounds which can be muddy, wet, or contain or present other hazards.

I hereby specifically and forever waive and release Horses for Good and its officers, directors, employees, volunteers and agents from any liability for injury or property damage arising out of the inherent risks of equine activities or participating in a training or livery yard environment and/or with horses, as well as from the negligence of Horses for Good, its officers, directors, employees, volunteers and agents.

By signing this agreement, I hereby acknowledge that there will not be a nurse on the premises and Horses for Good and its principals, employees and agents bear no responsibility for my health and medical care.

I agree to indemnify, save and hold harmless Horses for Good and its officers, directors, employees, volunteers and agents from and against any loss, liability, damage, legal fees or costs arising out of or in any way connected with (i) my presence or participation at Horses for Good's facility, (ii) contagious disease carried by equines brought by me to Horses for Good, or (iii) any acts or omissions of Horses for Good and its officers, directors, employees, volunteers and agents.
